All charges are due and payable upon receipt of the delivery invoice and shall become delinquent after 10 days. A finance charge of 1.5% (or a minimum of \$1.00) may be assessed after 15 days on unpaid balances including any previous finance charge. Annual percentage rate is 18%. The customer agrees to pay reasonable attorney and/or collection costs at a maximum rate of 30%, which may be incurred in securing payments for service and/or material supplied. It is our policy NOT to deliver gas to any customer with a past due balance. If we are unable to deliver gas to you on your scheduled route day because your account was past due or accessibility issues, and you need gas before your next scheduled route day, there will be an additional \$75 charge to deliver gas to you. We offer billing to customers with a good credit standing only. Customers not paying within terms will be assigned a credit limit or placed on a COD basis. Customers not paying within terms (net 10) may have gas service locked off. Customers who have their gas service locked off will be charged a \$75.00 non-refundable lock off fee. To reinstate service, customer must pay the full past due balance and the \$75 non-refundable lock off fee. A \$25 service charge plus the original check amount must be paid on each returned check within 10 days. Accepted forms of repayment of returned checks are cash, cashier's check, or money order. The customer grants 49'R Propane full access to the premises for the purpose of delivering gas and for installing, maintaining, servicing, or removing the company owned equipment.
